## COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE AND PROPOSED PROCEDURAL SCHEDULE

On August 4, 2022, McIlrath Properties LLC (McIlrath) filed a petition appealing the decision of Miller Grove Water Supply Corporation (Miller Grove) regarding the cost of obtaining service under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On September 12, 2022, the administrative law judge (ALJ) filed Order No. 3, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice by September 26, 2022. Therefore, this pleading is timely.

### I. NOTICE

Notice in this proceeding is governed by 16 TAC § 22.55. Staff recommends that the only entity affected by this appeal is Miller Grove, and therefore, it is reasonable to require McIlrath to provide notice to Miller Grove. It is unclear from McIlrath's filing whether a copy of the appeal was mailed to Miller Grove. If McIlrath did not mail a copy to Miller Grove, Staff recommends that they be directed to do so and include the assigned Docket No. 53933. Staff further recommends that McIlrath file in the docket proof that a copy of the appeal was mailed to Miller Grove's address on record.

## II. PROPOSED PROCEDURAL SCHEDULE

In accordance with Staff's comments, Staff proposes the following procedural schedule:

Staff recommends that the proposed procedural schedule be adopted. Staff respectfully requests that an order be issued consistent with the foregoing recommendations.
