COMMISSION STAFF'S REQUEST FOR EXTENSION

On August 4, 2022, McIlrath Properties LLC (McIlrath) filed a petition appealing the decision of Miller Grove Water Supply Corporation (Miller Grove) regarding the cost of obtaining service under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g).

On September 26, 2022, the administrative law judge (ALJ) filed Order No. 4, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file its final recommendation or request a hearing by November 21, 2022. Therefore, this pleading is timely.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On October 24, 2022, Miller Grove filed its responses to Staff's first requests for information (RFI) to the water supply corporation. Staff needs additional time to review the responses filed by McIlrath before assessing whether to request a hearing in the matter. Staff also needs to confer with McIlrath to discuss the most efficient way to proceed with this docket. As such, Staff respectfully requests that the deadline to file its final recommendation or request a hearing be extended until December 13, 2022.

III. CONCLUSION

Staff respectfully requests that its deadline to file its final recommendation or request a hearing be extended until December 13, 2022.
