

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following:

The requested area includes <u>135</u> customer connections, is located approximately <u>1.4</u> mile(s) <u>northeast</u> of downtown <u>Pine Grove</u>, Texas, and is generally bounded on the north by <u>Harris and Montgomery County Line</u>; on the east by <u>Lee Road</u>; on the south by <u>Kennemer Drive and Field Cottage Lane</u>; and on the west by <u>Fox Walk Trail and Fox Swift Court</u>.

The requested area includes approximately <u>84</u> acres, comprised of transferred area from Oak Hill Estates Water Company, LLC (CCN No. 12861) to CSWR-Texas (CCN No. 13290).

The application proposes the subtraction of approximately <u>84</u> acres from CCN No. 12861 and the addition of approximately <u>84</u> acres to CCN No. 13290.

This transaction will not have an effect on the current customer's rates and services.

The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice,

whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.


If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. 
