**ORDER NO. 5  
EXTENDING 120-DAY DEADLINE FOR GOOD CAUSE**

This Order addresses the status of this docket and the need to extend the 120-day administrative deadline for the Commission to determine whether a public hearing should be required to determine if the application is in the public interest. In Order No. 6 of Docket No. 53721,<sup>1</sup> the administrative law judge (ALJ) required Commission Staff to clarify whether the financial information provided by CSWR-Texas Utility Operating Company, LLC meets the requirements of 16 Texas Administrative Code (TAC) § 24.11(e) and answer two questions. Commission Staff's response to Order No. 6 in Docket No. 53721 may implicate the processing of CSWR-Texas's other dockets, including this one, currently pending before the Commission.

Therefore, in order for full analysis of Commission Staff's response to Order No. 6 in Docket No. 53721 to occur, the ALJ extends the 120-day deadline in 16 TAC § 24.239(h) for good cause under 16 TAC § 24.2(b) to 60 days after the date that Commission Staff files their response to Order No. 6 in Docket No. 53721.
