**ORDER NO. 13  
REQUIRING ADDITIONAL CLARIFICATION**

This Order addresses the sufficiency of notice of Stonetown Royal Coach Utilities, LLC and Trinity RCT GP LLC's application for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County.

On May 30, 2023, the applicants filed its response to Order No. 11, which included the supplemental affidavit of Adam Minnick, authorized representative of Stonetown MRE Texas, LLC, attesting that Stonetown MRE Texas is the sole landowner in the requested area and, consequently, there is no other owner of a tract of land that is at least 25 acres and is wholly or partially included in the requested area according to the most current tax appraisal rolls of the applicable central appraisal district at the time the Commission received the application.

On June 30, 2023, Commission Staff filed its recommendation on the supplemented notice.

The administrative law judge requires additional clarification on the following issues:

1. The relationship between Stonetown MRE Texas and Stonetown Royal Coach Utilities such that an affidavit from an authorized representative for Stonetown MRE Texas is capable of satisfying Stonetown Royal Coach Utilities' obligations in this proceeding; and
2. Whether the evidence in this docket is sufficient to show that Stonetown MRE Texas received notice of this proceeding given that it is not listed as an entity having received notice in Stonetown Royal Coach Utilities' proof of notice filed on November 3, 2022.<sup>1</sup>
