STONETOWN ROYAL COACH UTILITIES, LLC’S RESPONSE TO ORDER NO. 13

Stonetown Royal Coach Utilities, LLC (Royal Coach) files this Response to Order No. 13, and in support thereof would show the following:

I. BACKGROUND

On August 5, 2022 the Applicants filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County. Specifically, Royal Coach seeks approval to acquire facilities and to transfer all of the water and sewer service area from Trinity under water Certificate of Convenience and Necessity (CCN) No. 13241 and sewer CCN No. 21090 (Application). Royal Coach also seeks to obtain CCN No. 13305 for water service and CCN No. 21133 for sewer utility service. The requested water and sewer service area includes approximately 15 acres and 118 customer connections.

On July 5, 2023, the Administrative Law Judge (ALJ) issued Order No. 13, establishing a deadline of July 14, 2023 for Royal Coach to provide clarification regarding the relationship between Royal Coach and Stonetown MRE Texas, and whether the evidence in this docket is sufficient to show that Stonetown MRE Texas received notice of this proceeding. Therefore, this pleading is timely filed.

II. RESPONSE TO ORDER NO. 13

Royal Coach respectfully directs the ALJ to its Third Supplement to the Application filed on January 11, 2023 which included, among other information, an organizational chart illustrating that Royal Coach is a wholly-owned subsidiary of Stonetown MRE Texas.¹ Further, Stonetown

MRE Texas is listed in the Application as the 100 percent owner of Royal Coach and states that equity financing will be provided by Stonetown MRE Texas in certain instances to meet Royal Coach's obligations.² Finally, Stonetown MRE Texas and Royal Coach share the same officers and those officers have executed the affidavits in question on behalf of Stonetown MRE Texas.³ Consequently, Stonetown MRE Texas as the parent company and sole owner of Royal Coach is capable of satisfying Royal Coach's obligations in this proceeding. The same parent-subsidary relationship was present in Docket No. 53937, a notice of approval for which was recently issued on June 29, 2023.

As to the issue of notice, Royal Coach's Supplemental Affidavit Regarding Notice filed on May 30, 2023 in this proceeding indicates that Stonetown Texas MRE is the sole landowner of the certificated area. Further, the evidentiary record reflects that Stonetown MRE Texas has been an active participant throughout the processing of Royal Coach's Application.⁴ Consequently, there is sufficient evidence in the record to show that Stonetown MRE Texas received notice of this proceeding.

III. CONCLUSION

Therefore, based on the foregoing discussion, Royal Coach respectfully requests that the ALJ issue a Notice of Approval in this proceeding and requests any and all other relief to which Royal Coach is entitled.




