ORDER NO. 14
FINDING NOTICE, AS SUPPLEMENTED, SUFFICIENT AND
ADMITTING ADDITIONAL EVIDENCE

This Order addresses the sufficiency of notice and the unaddressed motions to admit evidence that have been filed in this proceeding.

I. Notice

On May 30, 2023, Stonetown Royal Coach Utilities, LLC filed the affidavit of Adam Minnick, Stonetown MRE Texas, LLC's authorized representative, the immediate parent company of Stonetown, attesting that Stonetown MRE Texas is the sole landowner in the requested area and there is no other owner of a tract of land that is at least 25 acres and is wholly or partially included in the area proposed to be certified according to the most current tax appraisal rolls of the applicable central appraisal district at the time the Commission received the application.

The administrative law judge (ALJ) finds the notice, as supplemented, sufficient.

II. Evidence

Motions to admit evidence were filed on June 2, 5, and 16, 2023. The ALJ grants the motions and admits the following evidence into the record of this proceeding:

1. Proof of completed transaction filed on March 10, 2023;
2. Commission Staff's recommendation on sufficiency of closing documents filed on March 27, 2023;
3. The applicants' consent forms filed on May 17, 2023;
4. The applicants' supplemental affidavit regarding notice filed on May 30, 2023;
5. The certificates and tariffs attached to the joint supplemental motion to admit evidence and joint proposed notice of approval filed on June 2, 2023;

6. The map attached to the amendment to the joint supplemental motion to admit evidence filed on June 5, 2023;
7. The executed agreement between Flow-Tech Utility, Inc. and Stonetown MRE Texas for a licensed operator to operate and maintain facilities filed on June 16, 2023; and
8. Commission Staff's recommendation on the sufficiency of supplemental notice filed on June 30, 2023.
