STONETOWN WINDFERN UTILITIES, LLC PROOF OF NOTICE

Stonetown Windfern Utilities, LLC ("Windfern") submits this Proof of Notice in response to Order No. 4, which was issued in this proceeding on October 3, 2022. Order No. 4 directed Windfern to submit this Proof of Notice by November 14, 2022. Therefore, this pleading is timely filed.

Attached to this pleading as "Exhibit 1" is an Affidavit of Notice to Neighboring Utilities, Districts, Cities, and Affected Parties along with a copy of the example notice, including the maps that were attached to the notice, and a list of all recipients to whom notice was provided, including those entities Staff specifically requested Windfern to notify. Also attached as "Exhibit 2," is an Affidavit of Notice to Current Customers attesting to the service of individual notice to all current customers at the time notice was provided, as well as an example of the notice provided, including the maps that were attached to the notice. The notice and proof of notice are provided in the form and manner described by Ms. Mathis' memorandum attached to Commission Staff's recommendation issued on September 30, 2022. Notice to neighboring utilities, districts, cities, and affected parties was mailed on October 18, 2022 and notice to all current customers was mailed on October 19, 2022.

With regard to the example notice included in Exhibit 2, the notice to current customers provides October 20, 2022 as the "Date Notice Mailed" at the top of the form. However, the Affidavit of Notice to Current Customers correctly states that notice to current customers was mailed on October 19, 2022. Due to this inconsistency, and to the extent it is deemed necessary by the Administrative Law Judge ("ALJ"), Windfern respectfully requests a good cause exception under 16 Texas Administrative Code ("TAC") § 24.2(b) because while 16 TAC

§ 24.239(c) requires notice to be provided "on the form prescribed by the commission," the notice mailed to current customers on October 19, 2022 meets all the requirements specified in 16 TAC § 24.239(c)(1)(A)-(D). Consequently, there is no substantive or procedural harm that results from the notice being mailed one day earlier than stated on the form notice. Windfern has conferred with Commission Staff who has indicated that it supports the granting of a good cause exception.

Therefore, Windfern respectfully requests that the ALJ issue an order deeming the notice provided to neighboring utilities, districts, cities, affected parties, and current customers sufficient and, to the extent necessary, granting Windfern's request for a good cause exception.




