SECOND SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

Stonetown Windfern Utilities, LLC (Windfern) and Trinity @ Windfern LLC (Trinity) (collectively, the Applicants) file this Second Supplemental Motion to Admit Evidence. In support thereof, the Applicants would show the following:

I. BACKGROUND

On August 5, 2022 the Applicants filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County. Specifically, Windfern seeks approval to acquire facilities and to transfer all of the water and sewer service area from Trinity under water Certificate of Convenience and Necessity (CCN) No. 13239 and sewer CCN No. 21088 (the Application). Windfern also seeks to obtain CCN No. 21135 for sewer utility service and CCN No. 13307 for water utility service. The requested water and sewer service area includes approximately 10 acres and 92 customer connections.

On June 12, 2023, the Administrative Law Judge (ALJ) issued Order No. 14, establishing a deadline of June 20, 2023 for the Applicants to file a copy of an executed agreement for a licensed operator to operate and maintain the water and sewer system being transferred in this proceeding. Therefore, this pleading is timely filed.

II. SECOND SUPPLEMENTAL MOTION TO ADMIT EVIDENCE




