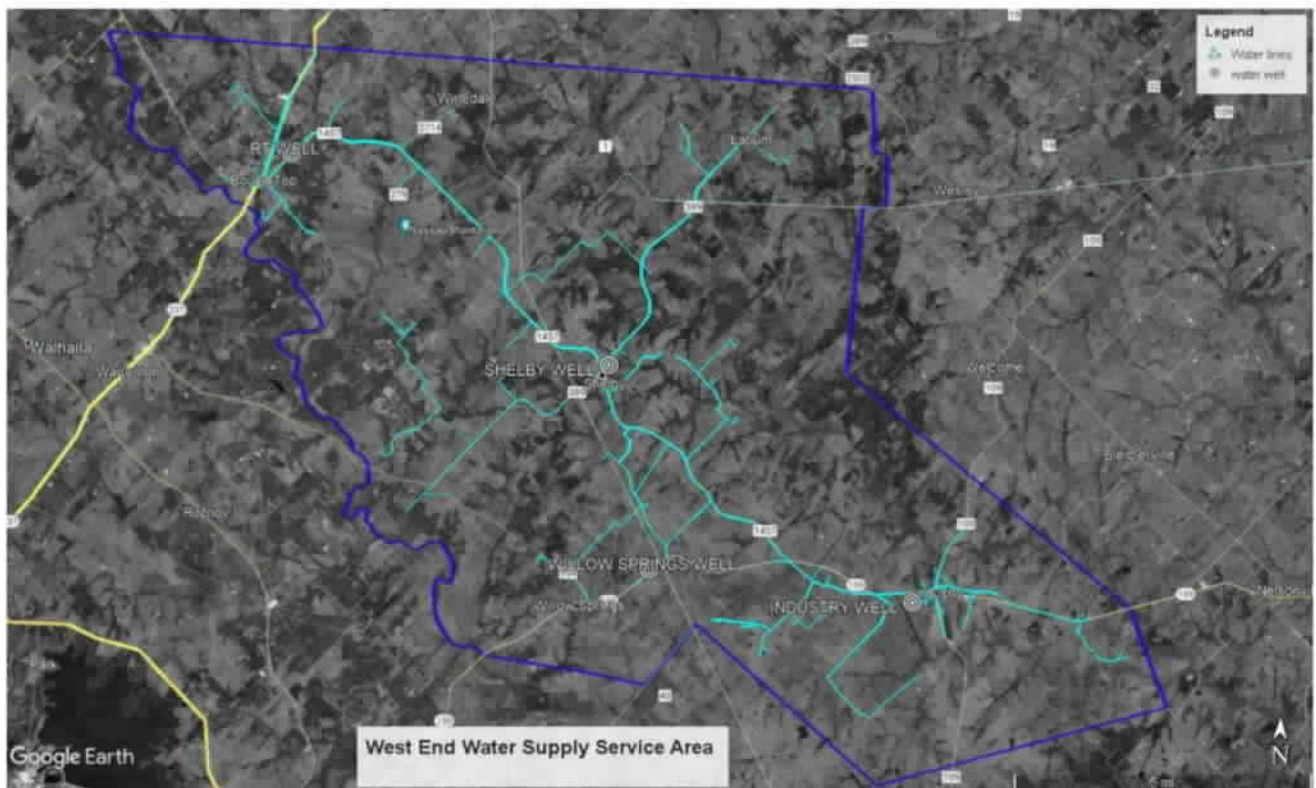

West End Water Supply Corporation building is located at 17210 Fordtran Blvd, Industry, Tx 78944. The Corporation has four water wells. Well #1 and well #2 receive water from the Gulf Coast Aquifer. Well #3 and well #4 receive water from the Yegua Jackson Aquifer.



Well #1: Industry Well is located at 2279 Main St. Industry, Tx 78944. The service area is located in Austin County and electric service is provided by Bluebonnet Electric. The Willow Springs well is also a contributing source for water to Well #1. There are approximately 218 active connections.

Well #2: Shelby Well is located at 832 FM 389, Fayetteville, Tx 78954. The well services parts of Austin County, Washington County, and Fayette County. Electric service is provided by Fayette Electric Cooperative, Inc. The Willow Springs well is also; a contributing source for water to Well #2. There are approximately 172 active connections.

West End Water Supply Corporation: Has a portable diesel generator.

Well #3: The Willow Springs Well is located at 8081 Hwy 159, Fayetteville, Tx 78954. The well services parts of Austin County and Fayette County. Electric service is provided by Fayette Electric Cooperative, Inc. The location has a propane generator. There are approximately 294 active connections.

Well # 4: The Round Top Well is located at 720 FM 1457, Round Top, Tx. The well services Fayette County. The Electric service provider is Fayette Electric Cooperative, Inc. The location also has a propane Generator. There are approximately 193 active connections.
