In compliance with 2022 PUCT Project 53938, Critical Load Facilities Information for Palo Duro Service Company, Inc. (CCN 12200) and its associated Public Water Systems identified below is being provided to the entities addressed above.

### Aledo Ridge (PWS #1840185)

Aledo Ridge, located in Parker County, is a public water system with a connection count of 26. Accessed from White Settlement Road, the water system shows to be serviced by two water

wells, G1840185A which produces 18 gallons per minute, and G1840185B which produces 17 gallons per minute for a combined production of 35 gallons per minute. Facilities consists of one 900 gallon and one 220-gallon hydro-pneumatic tank, and three distribution pumps all rated at 40 gallons per minute. Two 20,000 GSTs provide storage.

### Glider Base Estates (PWS #2490028)

Glider Base Estates, located in Wise County, is a public water system with a connection count of 129. The water system is serviced by four water wells, G2490028A produces 9 gallons per minute, G2490028B produces 10 gallons per minute, G2490028C produces 8 gallons per minute, and G2490028D produces 9 gallons per minute, for a combined production of 36 gallons per minute.
