On August 18, 2022, Entergy Texas, Inc. (ETI) filed an application to revise its fuel factors using the formula approved in docket No. 32915. On August 19, 2022, the Public Utility Commission of Texas (Commission) referred the docket to the State Office of Administrative Hearings to conduct a hearing and issue a proposal for decision if necessary to resolve any issues that are contested by the parties.

On August 22, 2022, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of August 24, 2022, for Commission Staff (Staff) to file its recommendation on the sufficiency of ETI's Application and proposed notice.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs more time to prepare its recommendation on the sufficiency of ETI's application and proposed notice. Therefore, Staff respectfully requests that its deadline be extended to August 31, 2022.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending the deadline Staff to file its recommendation on the sufficiency of ETI's Application and proposed notice to August 31, 2022.
