RE:	March 23, 2023 Open Meeting – Item No. 11 Docket No. 54017 – Application of Park Water Company to Extend the Time to File a Rate Application in Accordance with Notice of Approval in Docket No. 49311

A proposed order in the above-referenced docket is posted for consideration and action by the Commission. If the Commission approves the proposed order, I recommend the following changes.

The introductory paragraph should be modified to reflect that the deadline for Park Water to file its rate change application is set by 16 Texas Administrative Code (TAC) § 24.25(b)(1)(C).

This Order addresses Park Water Company's application for a good-cause exception to extend the deadline to file a rate change application prescribed in 16 Texas Administrative Code (TAC) § 24.25(b)(1)(C).-and-Ordering Paragraph 8-of the Notice of Approval in Docket No. 49311.<sup>4</sup> The Commission grants Park Water's request for a good-cause exception and extends Park Water's deadline to file a rate change application to February 22, 2023.

Finding of fact 4 should be modified to reflect that the deadline for Park Water to file its rate change application is set by 16 TAC 24.25(b)(1)(C).

4. On March 10, 2020, a Notice of Approval was filed in Docket No. 49311 which required, among other things, Park Water to file a rate change application <u>under 16</u> <u>TAC § 24.25(b)(1)(C)</u> within 18 months from the date the company began providing water service.<sup>13</sup>

Conclusion of law 6 should be modified to reflect that the deadline for Park Water to file its rate change application is set by 16 TAC § 24.25(b)(1)(C).

6. Under 16 TAC § 24.25(b)(1)(C) and Ordering Paragraph 8 of the Notice of Approval issued in Docket No. 49311, Park Water's deadline to file a rate change application with the Commission was February 1, 2022.

Conclusion of law 8 should be modified to reflect that the deadline for Park Water to file its rate change application is set by 16 TAC § 24.25(b)(1)(C).

 There is good cause to extend the deadline for Park Water to file a rate change application specified in 16 TAC § 24.25(b)(1)(C)-and-Ordering Paragraph 8 of the Notice of Approval in Docket No. 49311.

Additionally, the Commission should delegate to the Office of Policy and Docket Management the authority to modify the order to conform to the Citation and Style Guide for the Public Utility Commission of Texas and to make other non-substantive changes to the order for such matters as capitalization, spelling, grammar, punctuation, style, correction of numbering, and readability.
