**SUPPLEMENTAL MOTION TO ADMIT EVIDENCE**

CSWR-Texas Utility Operating Company, LLC (“CSWR-Texas”) files this Supplemental Motion to Admit Evidence. In support thereof, CSWR-Texas shows the following:

**I. BACKGROUND**

On August 10, 2023, the ALJ filed Order No. 11 requiring an affidavit attesting that CSWR-Texas reviewed the area proposed to be certified along with the Brazoria County tax appraisal maps and determined that there are no parcels of land at least 25 acres that are wholly or partially included in the proposed area. CSWR-Texas provided this affidavit in its Response to Order No. 11. On August 18, 2023, the ALJ filed Order No. 12 finding supplemental proof of notice sufficient and soliciting a motion to admit evidence. CSWR-Texas submits this Supplemental Motion to Admit Evidence and requests that the ALJ admit CSWR-Texas’s Response to Order No. 11. Counsel for CSWR-Texas has conferred with counsel for Staff of the Public Utility Commission of Texas (“Commission Staff”) and is authorized to state that Commission Staff is unopposed to this motion.

**II. MOTION TO ADMIT EVIDENCE**

The parties move to admit the following items into the record evidence of this proceeding:

1. CSWR-Texas’s Response to Order No. 11, with the attached affidavit of Eric Rocchio. (Interchange Item No. 47).


**III. CONCLUSION**
