**JOINT EXTENSION REQUEST**

On November 27, 2023, the administrative law judge (“ALJ”) issued Order No. 16, directing the parties to file a request for hearing or a joint motion to admit evidence and proposed notice of approval by December 13, 2023. CSWR-Texas Utility Operating Company, LLC (“CSWR-Texas”) and Staff of the Public Utility Commission of Texas (“Commission Staff”) timely file this Joint Extension Request to extend that deadline until December 29, 2023 so that CSWR-Texas and Lincecum’s Water Well Service (“Lincecums”) can execute revised tariff consent forms.

Subsequent to CSWR-Texas and Lincecums filing their tariff consent forms on June 30, 2023, CSWR-Texas obtained approval for interim rates in its currently pending rate case, Docket No. 54565.<sup>1</sup> Accordingly, so that the tariffs ultimately consented to and approved in this proceeding reflect the interim rate provisions from Docket No. 54565, CSWR-Texas and Lincecums must review and approve new tariff consent forms. Until that is finished, the parties cannot submit a proposed notice of approval with the accurate tariffs to be approved in this proceeding. Thus, this extension request is reasonable and good cause exists under 16 Tex. Admin. Code § 22.4 for the extension.




