**JOINT REQUEST FOR EXTENSION**

On August 31, 2022, CSWR-Texas Utility Operating Company, LLC and Ville D’Alsace Water Supply, LLC (collectively, Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Medina County.

On August 31, 2022, the administrative law judge (ALJ) filed Order No 1, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and proposed notice by October 3, 2022. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), parties may request that the time allowed for filing any documents be extended for good cause. The Applicants and Staff (collectively, the Parties) have conferred and note that the Applicants intend to file an amended application. Accordingly, in the interest of the efficient processing of this docket, the Parties respectfully request an extension until October 30, 2022 for the Applicants to file an amended application. The Parties further request that Staff be given 30 days from the date the amended application is filed to file a supplemental recommendation on the amended application.
