COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

I. INTRODUCTION

On August 31, 2022, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Ville D'Alsace Water Supply, LLC (Ville D'Alsace) (collectively, Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Medina County. CSWR-Texas filed supplemental information on September 7 and 15, 2022, October 5, 2022, and December 2, 2022.

On November 7, 2022, the administrative law judge (ALJ) filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice by December 29, 2022. Therefore, this pleading is timely filed.

II. RECOMMENDATION ON NOTICE

Staff has reviewed the proof of notice provided by CSWR-Texas and recommends that the notice is sufficient. Specifically, CSWR-Texas provided an affidavit of notice dated November 15, 2022, and signed by Aaron Silas, Director of Regulatory Operations of CSWR-Texas, that notice was provided on November 14, 2022, to its current customers, neighboring utilities, and affected parties, as well as the maps that were attached to the provided notice. Therefore, Staff recommends that the notice provided by CSWR-Texas be deemed sufficient for further processing of this matter.

III. CONCLUSION

For the reasons detailed above, Staff recommends that the notice be found sufficient and respectfully requests entry of an order consistent with this pleading.
