

“My name is Mark L. Urback. I am over the age of eighteen years, of sound mind, and am capable of making this affidavit. The facts stated in the affidavit are within my personal knowledge and are true and correct.


I am the Vice President of Engineering and Construction of Quadvest, LP (Quadvest), the Applicant in the above-captioned matter.

Pursuant to Order No. 7 issued by ALJ in this matter, by June 9, 2023, Quadvest must file an affidavit that notice has been mailed by first-class mail to each owner of a tract of land that is at least 25 acres and is wholly or partially included in the area proposed to be certified according to the most current tax appraisal rolls of the applicable central appraisal district at the time the Commission received the application for the CCN amendment. Further, Quadvest must supplement its proof of notice by providing a copy of applicable appraisal district maps overlaid with the requested area, a list of the landowners with properties wholly or partially in the requested area, and the acreage owned by each listed owner. If there are no landowners with a tract of land that is at least 25 acres and is wholly or partially included in the requested area, Quadvest must file an

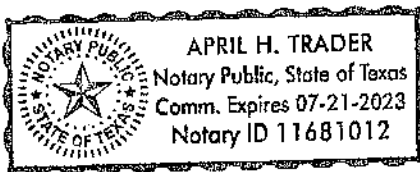
affidavit confirming the same.


There are no owners of a tract of land that is at least 25 acres and is wholly or partially included in the area proposed to be certified other than the developer requesting the service. Accordingly, there was no owner to which to provide notice and therefore no such notice was provided.”
