#### COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND NOTICE

#### I. INTRODUCTION

On September 8, 2022, Kaufman Independent School District (Kaufman ISD) filed a petition for streamlined expedited release from College Mound Water Supply Corporation<sup>1</sup> (College Mound WSC) water Certificate of Convenience and Necessity (CCN) No. 10825 in Kaufman County, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Kaufman ISD asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Kaufman County, which is a qualifying county.

On August 9, 2022, the administrative law judge (ALJ) filed Order No. 1, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the petition and notice by October 7, 2022. Therefore, this pleading is timely filed.

#### **II. REQUEST TO RESTYLE DOCKET**

On September 8, 2022, Kaufman ISD filed its application for streamlined expedited release in Kaufman County. Staff respectfully requests that the docket be restyle to "*Petition of Kaufman Independent School District to Amend College Mound Water Supply Corporation's Certificate of Convenience and Necessity in Kaufman County by Streamlined Expedited Release.*"

<sup>&</sup>lt;sup>1</sup> The name for the utility currently reflected on the CCN is College Mound Water Supply Corporation. On November 19, 2013, College Mound Water Supply Corporation changed their name to College Mound Special Utility District with the Texas Commission on Environmental Quality. Staff intends to open a project to change the name in the utility database and to update College Mound Water Supply Corporation's CCN; however, the project would not be completed prior to the completion of the present docket. Accordingly, Staff uses the name College Mound Water Supply Corporation as it is the name reflected on the entity's CCN.

#### **III. ADMINISTRATIVE COMPLETENESS**

Staff has reviewed the petition and, as detailed in the attached memorandum from Chase Lipscomb, Infrastructure Division, recommends that the petition is administratively complete. Staff's recommendation on administrative completeness is not a comment on the merits of the petition.

### **IV. NOTICE SUFFICIENCY**

Under 16 TAC § 24.245(h)(3)(f), a landowner seeking streamlined expedited release must provide proof that a copy of the petition has been mailed to the current CCN holder via certified mail on the day that the landowner submits the petition to the Commission. Kaufman ISD stated that it mailed a copy of its petition to the CCN holder, College Mound WSC, by certified mail on the day the petition was filed with the Commission. Kaufman ISD also included an affidavit attesting to this provision of notice to College Mound WSC. Accordingly, Staff recommends that the notice is sufficient.

### V. PROCEDURAL SCHEDULE

Under 16 TAC § 24.245(h)(7), there is an expedited deadline of 60 days for approval of the requested release that begins once the ALJ issues an order finding a petition administratively complete. Staff recommends that the petition be found administratively complete. Therefore, Staff proposes the following procedural schedule and requests that the ALJ populate the deadlines accordingly when the ALJ issues that order.

Deadline for reports from petitioner's appraiser and College Mound WSC's appraiser	Within 70 days after the Commission approves streamlined expedited release
Deadline for Staff's appraiser's report	Within 100 days after the Commission approves streamlined expedited release
Deadline for Commission's final order determining the amount of monetary compensation, if any, owed by petitioner to College Mound WSC	Within 60 days after the Commission receives the final appraisal
Deadline for petitioner to pay any compensation due to College Mound WSC	Within 90 days of the Commission's final order on compensation

## VI. CONCLUSION

For the reasons detailed above, Staff recommends that the petition be found administratively complete, that the notice be found sufficient, and that the proposed procedural schedule be adopted. Staff respectfully requests the entry of an order consistent with these recommendations.

<sup>3</sup> It is critical for Staff to know as soon as possible after the Commission grants the petition whether Staff needs to secure the services of a third appraiser. If the petitioner and CCN holder are unable to agree and fail to make this filing, Staff may need additional time to file its appraiser's report.

On September 8, 2022, Kaufman Independent School District (Kaufman ISD) filed a petition for streamlined expedited release from College Mound Water Supply Corporation (College Mound WSC) water Certificate of Convenience and Necessity (CCN) No. 10825 in Kaufman County, under Texas Water Code (TWC) § 13.2541(b) and 16 Texas Administrative Code (TAC) § 24.245(h). Kaufman ISD asserts that the land is at least 25 contiguous acres, is not receiving water service, and is located in Kaufman County, which is a qualifying county.

Staff notes that the current style of this docket is "Petition of Kaufman Independent School District to Amend College Mound Special Utility District's Certificate of Convenience and Necessity in Kaufman County by Streamlined Expedited Release." Staff requests that the style of the docket be changed to "Petition of Kaufman Independent School District to Amend College Mound Water Supply Corporation's Certificate of Convenience and Necessity in Kaufman County by Streamlined Expedited Release."

Kaufman ISD submitted a sworn affidavit attesting that the tract of land was not receiving water service from College Mound WSC and a warranty deed confirming ownership of the landowner's total property. Kaufman ISD included a statement indicating a copy of the petition was sent via certified mail to College Mound WSC on the date the petition was filed with the Commission.

Based on the mapping review by Dave Babicki, Infrastructure Division, the maps submitted with Item 1 on September 8, 2022 are sufficient for determining the location of the tract of land considered for streamlined expedited release is located within College Mound WSC's water CCN.

The landowner's total property is approximately 85.2 acres. The tract of land in the petition for streamlined expedited release is approximately 85.2 acres, of which approximately 26.2 acres overlap College Mound WSC (CCN No. 10825) and would be decertified from CCN No. 10825.

Based on my technical and managerial review and the mapping review by Dave Babicki of the information provided by Kaufman ISD, I recommend the petition be deemed administratively complete and accepted for filing.
