**KAUFMAN INDEPENDENT SCHOOL DISTRICT'S  
RESPONSE TO ORDER NO. 2**

TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW, Kaufman Independent School District (the Petitioner), by and through its undersigned attorney of record, and files this Response to Order No. 2 (Response).

On September 8, 2022, Petitioner filed a Petition to Amend North Kaufman Water Supply Corporation's (North Kaufman WSC) Water Certificate of Convenience and Necessity (CCN) No. 11205 in Kaufman County, Texas by Streamlined Expedited Release under Texas Water Code (TWC) § 13.2541 and 16 Texas Administrative Code (TAC) § 24.245(h). On October 11, 2022, the Public Utility Commission of Texas (Commission) Administrative Law Judge (ALJ) issued Order No. 2, finding the Petition administratively complete. Order No. 2 also established a procedural schedule, requiring the CCN holder to file a response to the Petition by October 31, 2022, and requiring the Petitioner to respond to the CCN holder's response by November 7, 2022. North Kaufman WSC did not file a response to the Petition by its deadline, to which this timely filed Response is required to address.

Accordingly, for the reasons above, Petitioner, Kaufman Independent School District reiterates its request that the Petition be granted in all respects and that the Commission enter an order releasing Petitioner's 56.26-acre tract from North Kaufman Water Supply Corporation's water CCN No. 11205 in Kaufman County, Texas and all other such relief to which it is entitled.
