# DOCKET NO. 54073 NOTICE OF HEARING ON PETITION

**PETITION:** Commission Staff's Petition to Appoint a Temporary Manager for Stone Hedge Utility Company, Inc.

On September 20, 2022, the Staff of the Public Utility Commission of Texas filed a petition to appoint a temporary manager to operate the water and sewer utility services of Stone Hedge Utility Company, Inc. Previously, the Commission appointed Undine Texas, LLC as the temporary manager of Stone Hedge Utility, with Undine serving a 180-day term that began on June 7, 2022 and is set to expire on December 4, 2022. The September 20, 2022 petition filed by Commission Staff requested that the Commission appoint Undine as temporary manager of Stone Hedge Utility for a new term to begin on December 3, 2022 and to continue until December 3, 2023.

Commission Staff's petition alleges that Stone Hedge Utility remains abandoned by its legal owners, that a proceeding to appoint a receiver for Stone Hedge Utility has been initiated in district court, and that no person associated with Stone Hedge Utility has attempted to resume management or operation of the utility since Undine was appointed as temporary manager of the utility on June 7, 2022.

Notice of Commission Staff's petition was mailed on September 20, 2022 to the last known address of Stone Hedge Utility and to the additional addresses listed in Commission Staff's petition.

The Commission has the authority to hold hearings and to appoint a temporary manager to an abandoned utility under Texas Water Code (TWC) §§ 13.041, 13.412(f), and 13.4132, as well as under 16 Texas Administrative Code (TAC) §§ 24.355 and 24.357.

HEARINGS ON THE PETITION: In accordance with Texas Government Code § 2001.051 and TWC § 13.4132, a hearing on the merits in this matter will be held at the Commission's Open Meeting scheduled to begin at 9:30 a.m. on October 20, 2022 in the Commissioners' Hearing Room, located at the William B. Travis Office Building, 1701 N. Congress Avenue, Seventh Floor, Austin, Texas 78701.

At the hearing on the merits, the Commission will consider evidence on whether to grant Commission Staff's petition to appoint a temporary manager for Stone Hedge Utility. An affected person may participate in the evidentiary hearing or waive the right to such hearing. The right to a hearing may be waived if the affected person provides the Commission

with written notice of its waiver of the right to hearing, or fails to attend the hearing. The hearing will be conducted in accordance with Chapter 2001 of the Texas Government Code, Chapter 13 of the TWC, and Commission rules under 16 TAC Chapters 22 and 24.

A prehearing conference will be held at <u>11:00 a.m. on October 19, 2022</u> in the Commissioners' Hearing Room, located at the William B. Travis Office Building, 1701 N. Congress Avenue, Seventh Floor, Austin, Texas 78701.

Persons planning to attend this hearing who have disabilities requiring auxiliary aids or services should notify the Commission as far in advance as possible so that appropriate arrangements can be made.
