**COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION**

**I. INTRODUCTION**

On September 15, 2022, Harrison Williams (Mr. Williams), owner of SP Utility Company, Inc. (SP Utility) and temporary manager of Villa Utilities, water Certificate of Convenience and Necessity (CCN) No. 12079, filed with the Public Utility Commission of Texas (Commission) a request for a temporary rate increase pursuant to Texas Water Code (TWC) § 13.046 and 16 Texas Administrative Code (TAC) § 24.363 in Chambers County, Texas. Villa Utilities has three active public water systems (PWS): Vista Utilities (PWS ID: 0360026), Reed Estates Water System (PWS ID: 1010945), and Villa Utilities (PWS ID: 101183). Mr. Williams filed supplemental information on November 18, 2022.

On December 1, 2022, the administrative law judge (ALJ) filed Order No. 5, requiring the Staff (Staff) of the Commission to request a hearing or file a recommendation on final disposition by January 12, 2023.

**II. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff requires additional time to finalize its recommendation on final disposition to ensure Staff has thoroughly reviewed the rates Staff will recommend. Thus, Staff respectfully requests that its deadline to file a recommendation on final disposition be extended to January 20, 2023.

**III. CONCLUSION**

Staff respectfully requests the entry of an order extending Staff's deadline to file a recommendation on final disposition to January 20, 2023.
