CONSOLIDATION OF MARILEE SPECIAL UTILITY DISTRICT INTO MUSTANG SPECIAL UTILITY DISTRICT

TO THE PUBLIC UTILITY COMMISSION OF TEXAS (COMMISSION):

COMES NOW Mustang Special Utility District (Mustang SUD) and files this documentation as evidence of the consolidation of the former Marilee Special Utility District (Marilee SUD) and Mustang SUD into the consolidated Mustang SUD.

I. Background

Marilee SUD and Mustang SUD were consolidated pursuant to Subchapter H, Chapter 65 of the Texas Water Code. The Texas Commission on Environmental Quality (TCEQ) has acknowledged the consolidation of the districts in its records as reflected in the TCEQ Water District Database.

The assets of Marilee SUD, including any customer deposits, fund balances and other property, have been transferred to the consolidated Mustang SUD. All business activities of the former Marilee SUD have been assumed by and incorporated into the consolidated Mustang SUD operations.

Marilee SUD provided water service under Certificate of Convenience and Necessity (CCN) No. 10150 in Collin County prior to consolidation with Mustang SUD and the consolidated Mustang SUD has assumed responsibility of CCN No. 10150. Mustang SUD is not currently seeking to change the boundaries of CCN No. 10150 as part of the consolidation process.

CONSOLIDATION AGREEMENT BY AND BETWEEN MUSTANG SPECIAL UTILITY DISTRICT AND MARILEE SPECIAL UTILITY DISTRICT

THIS CONSOLIDATION AGREEMENT (the "Agreement"), is made and entered into this day of August 2021, by and between Mustang Special Utility District ("Mustang"), a political subdivision of the State of Texas, operating under and governed by the provisions of Chapters 49 and 65, Texas Water Code, as amended, Chapter 7209. Texas Special Districts Local Laws Code, and Section 59 of Article XVI of the Texas Constitution, and Marilee Special Utility District ("Marilee"), a political subdivision of the State of Texas, operating under and governed by the provisions of Chapters 49 and 65, Texas Water Code, as amended, Chapter 7215, Texas Special Districts Local Laws Code, and Section 59 of Article XVI of the Texas Constitution, Mustang and Marilee are collectively referred to herein as the "Districts" or, individually, as a "District."

RECITALS

WHEREAS, Mustang encompasses an area of approximately (2) occ acres, as described on Exhibit
"A", attached hereto and made a part hereof for all purposes

WHEREAS, Marileo encompasses an area of approximately 51,000 acres, as described on Exhibit "B", attached hereto and made a part hereof for all purposes;

WHEREAS, the Boards of Directors of the Districts have each determined that it is in the best interests of the property owners and customers within both Districts to consolidate into one district as provided by Sections 65.723 – 65.726 of the Texas Water Code;

WHEREAS, Mustang and Marilee desire to enter into this Agreement for the purposes of setting forth the terms and conditions under which the two Districts will be consolidated into one district;

WHEREAS, the Boards of Directors of the Districts have determined to contract in the manner hereinafter set forth for the consolidation of the Districts and have further determined that the terms and conditions of this Agreement are desirable, fair and advantageous, and that the Districts are authorized to enter into this Agreement pursuant to the terms of Chapter 65, Texas Water Code, as amended, particularly Sections 65.723 – 65.726 thereof, and the Constitution and laws of the State of Texas.

AGREEMENT

For and in consideration of the premises and the mutual promises, covenants, obligations and benefits of this Agreement, Mustang and Marilee contract and agree as follows:

I. CONSOLIDATION ELECTION

Section 1.1: The Districts agree to proceed with all due diligence to consolidate Mustang and Marilee into one district (the "Consolidated District"), subject only to the passage of the elections hereinafter described (the "Consolidation Elections") and the remaining terms and conditions of the consolidation as set forth in this Agreement.

Section 1.2: Each of the Districts represents and confirms that it has not issued and outstanding bonds, notes or other obligations payable in whole or in part from taxation that would be subject to assumption by the other District.

Section 1.3: The Board of Directors of each District will proceed with all due diligence to call, hold and conduct on the November 2021 uniform election date an election in each District to approve the following terms and conditions of the consolidation:

PROPOSITION 1:

SHALL MARILEE SPECIAL UTILITY DISTRICT AND MUSTANG SPECIAL UTILITY DISTRICT BE AUTHORIZED TO CONSOLIDATE INTO ONE DISTRICT; AUTHORIZE THE NAME OF THE CONSOLIDATED DISTRICT TO BE MUSTANG SPECIAL UTILITY DISTRICT; AUTHORIZE BACH DISTRICT TO ASSUME THE OTHER DISTRICT'S BONDS, NOTES, OR OTHER OBLIGATIONS?

Section 1.4: The Consolidation Elections shall be held on the same day and the Board of Directors of each District shall give notice of its Consolidation Election for the time and in the manner provided by law for bond elections.

II. FAILURE OF CONSOLIDATION ELECTIONS

Section 2.1: In the event that any one or more of the propositions to be submitted at either of the Consolidation Elections relative to the consolidation of the Districts should fail to receive approval by a majority of votes cast at such elections relative to such proposition or propositions, then this Agreement shall, upon the official canvassing of the results of the Consolidation Elections, be automatically terminated and of no further force and effect.

Section 2.2: The Board of Directors of each District agree, in such event, to take such actions and proceedings and to pass, adopt, enter, approve and record such orders, resolutions and documents as may be necessary and appropriate to evidence the failure to consolidate the Districts into one district.

III. PASSAGE OF ELECTIONS

Section 3.1: Should all propositions submitted at both of the Consolidation Elections relative to the consolidation of the Districts receive approval by a majority of votes east at such elections, then the Boards of Directors of the Districts agree to promptly pass, adopt, enter, approve, and record in the manner required by law such orders, resolutions, and documents as may be necessary and appropriate to evidence the consolidation of the two Districts into one district.

IV. MANAGEMENT OF DISTRICTS BEFORE CONSOLIDATION

Section 4.1: The Board of Directors of each District agree to enter into the Management Agreement, attached hereto as "Exhibit C," effective September 1, 2021.

V. GOVERNANCE OF DISTRICTS AFTER CONSOLIDATION

Section 5.1: Provided that the Consolidation Elections are both successful, during the 90-day period after the date of the Consolidation Elections, the officers of each District shall continue to act jointly as officers of the original Districts to settle the affairs of the respective District.

Section 5.2: Provided that the Consolidation Elections are successful, the Districts agree that for a period of at least two years, the Consolidated District will maintain the same number of employee positions as the combined number of positions funded by each District at the time of the Consolidation Elections.

VI. GOVERNING THE CONSOLIDATED DISTRICT

Section 6.1: Following the expiration of the 90-day period set forth in Section 5.1 hereinabove, the nine officers of Mustang as of the date of the Consolidation Elections will act as officers of the Consolidated District.

Section 6.2: The nine officers shall continue in office for the remainder of the term of office each was elected prior to the Consolidation Election. The nine member board of the Consolidate District shall serve staggered three-year terms of office.

Section 6.3: All subsequent directors' elections for the Consolidated District shall be held annually.

VII. MAINTENANCE AND OPERATION FUNDING

Section 7.1: Upon consolidation, all fund balances and revenues of the Districts shall be deposited into the accounts of the Consolidated District.

VII. GENERAL PROVISIONS

- Section 8.1: This Agreement shall not be assignable by either District and may not be amended, altered or revised except by mutual written agreement of the Districts.
- Section 8.2: This Agreement shall be for the sole and exclusive benefit of Mustang and Marilee and shall not be construed to confer any benefits or rights upon any other parties.
- Section 8.3: This Agreement shall be and remain in full force and effect for a term commencing on the effective date of this Agreement and extending until (i) the official canvassing of the results of the Consolidation Elections which reflects the failure of either or both Consolidation Elections or (ii) 90 days after the official canvassing of the results of the Consolidation Elections which reflects the passage of both of the Consolidation Elections.
- Section 8.4: The covenants, agreements, and obligations made and undertaken by each District are material inducements to the other District to make and enter into this Agreement. If any material part or provision of this Agreement is determined by a court of competent jurisdiction to be void or unenforceable, the remaining provisions hereof shall likewise be void.

IX. ASSUMPTION OF CONTRACTUAL RIGHTS AND OWNERSHIP

- Section 9.1: Upon consolidation, the Consolidated District shall be the successor in interests to all existing agreements, commitments, contracts, duties, leases, liabilities, loans obligations, and rights of the District, and shall succeed as owner to all facilities and properties owned by either District.
- Section 9.2: Mustang and Marilee agree that any and all rights, titles, property and obligations of either District, contractual or otherwise, shall become the rights, titles, property and obligations of the Consolidated District.
- Section 9.3: The Districts agree to take such actions and proceedings and to pass, adopt, enter, approve and record such orders, resolutions and documents as may be necessary and appropriate to evidence the assumption by the Consolidated District of all rights, titles, property and obligations of Mustang and Marilee.

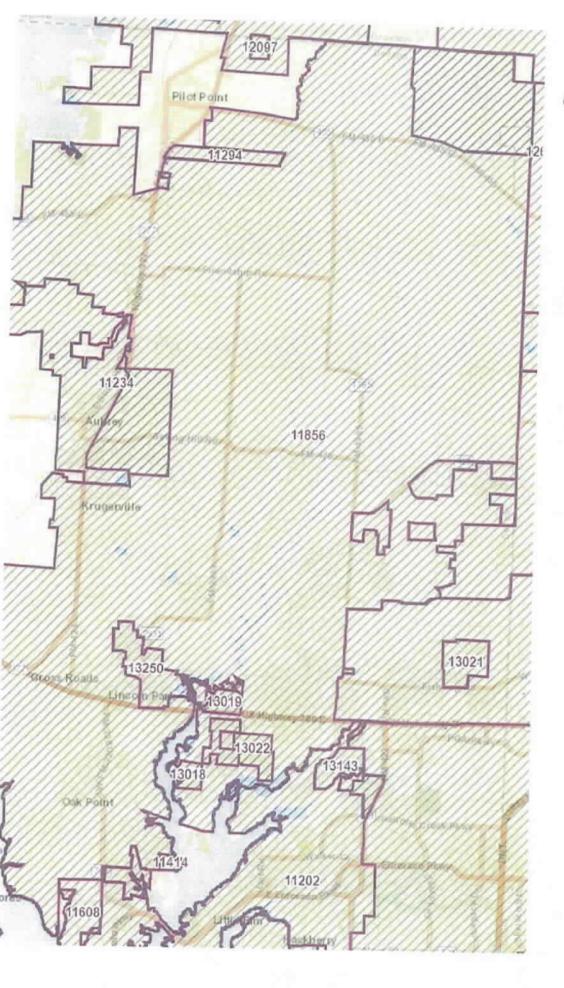
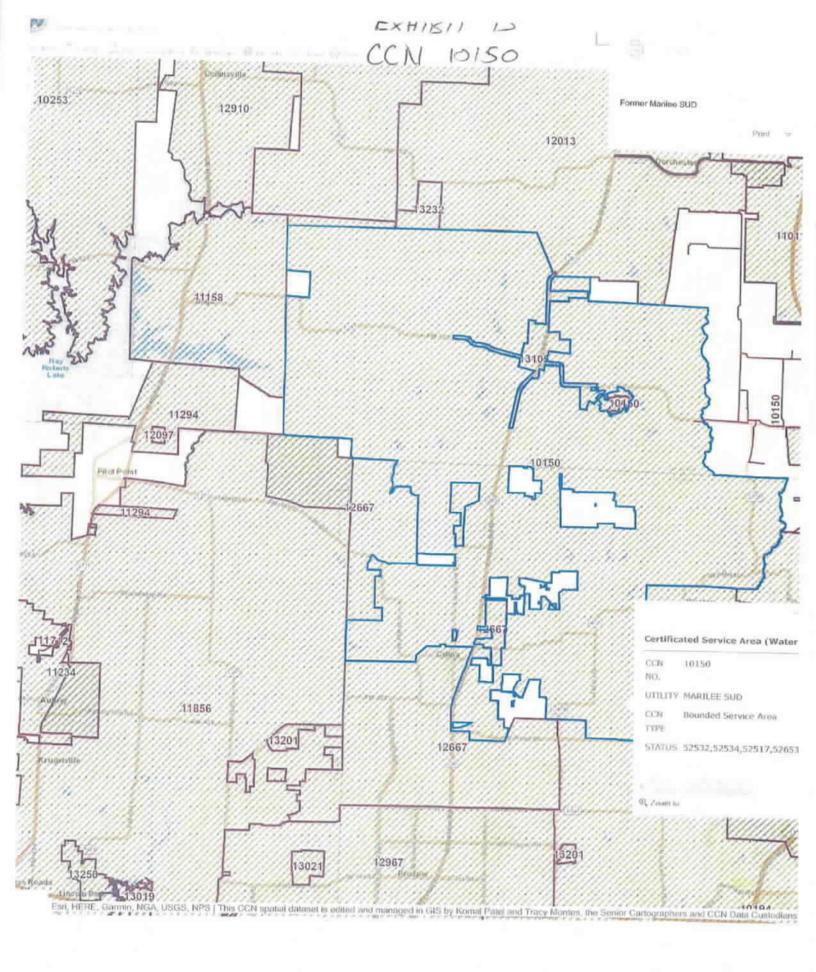

ORDER CALLING ELECTION TO AUTHORIZE CONSOLIDATION OF MARILEE SPECIAL UTILITY DISTRICT AND MUSTANG SPECIAL UTILITY DISTRICT

STATE OF TEXAS

COUNTIES OF GRAYSON AND COLLIN

WHEREAS, Marilee Special Utility District (the "District") was created and is operating under Article XVI, Section 59, of the Texas Constitution and Chapter 65 of the Texas Water Code and Chapter 7215 of the Special District Local Laws Code and is located in Grayson County and Collin County in Texas; and

WHEREAS, Mustang Special Utility District ("Mustang") was created and is operating under Article XVI, Section 59, of the Texas Constitution and Chapter 65 of the Texas Water Code and Chapter 7209 of the Special District Local Laws Code and is located in Denton County, Texas; and

WHEREAS, in accordance with Sections 65.723 and 65.724 of the Texas Water Code, the District may order an election on a proposition to authorize the District to consolidate with Mustang; and

WHEREAS, the Board of Directors of the District desires to order an election for November 2, 2021, the next available uniform election date, and appoint election officials required for the conduct of the election, and deems it advisable to call the election hereinafter ordered; and

WHEREAS, the District desires and intends to contract with Collin County to conduct its election and District customers residing in Grayson County will be permitted to vote on the District's election at the Collin County polling precincts within the boundaries of the District; and

WHEREAS, the meeting to adopt this Order was open to the public, and public notice of the time, place, and purpose of the meeting was given, all as required by Chapter 551, Government Code, as amended; and

THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF MARILEE SPECIAL UTILITY DISTRICT THAT:

Section 1: The matters and facts set out in the recitals of this Order are hereby found and declared to be true and complete.

Section 2: An election shall be held by the District between the hours of 7:00 a.m. and 7:00 p.m. on November 2, 2021, in the District at the Collin County precinct polling place locations within the boundaries of the District at which there shall be submitted the proposition authorizing consolidation of the District and Mustang.

Section 3: Voting in the election must be by the use of electronic ballots, or other methods as approved by law, and must be available in both English and Spanish and conform to the requirements of the Texas Election Code. Oral bilingual assistance must be available during the election and may be obtained by contacting the presiding judge or the alternate presiding judge at the polling location.

Section 4: At the election, the following PROPOSITION shall be submitted in accordance with the law:

PROPOSITION 1:

SHALL MARILEE SPECIAL UTILITY DISTRICT AND MUSTANG SPECIAL UTILITY DISTRICT BE AUTHORIZED TO CONSOLIDATE INTO ONE DISTRICT; AUTHORIZE THE NAME OF THE CONSOLIDATED DISTRICT TO BE MUSTANG SPECIAL UTILITY DISTRICT; AUTHORIZE EACH DISTRICT TO ASSUME THE OTHER DISTRICT'S BONDS, NOTES, OR OTHER OBLIGATIONS?

Each voter may vote for or against the proposition by placing an "X" in the square beside the word "FOR" or in the square beside the word "AGAINST".

Section 5: The election precinct(s) for the District exist as established by Collin County. The polling place for each such election precinct shall be the polling places established by Collin County for such election precincts in Collin County. Early voting dates, times, locations, as well as election day polling locations are as determined by Collin County.

The presiding judges, alternate presiding judges and clerks for the election selected and appointed by Collin County in compliance with the requirements of state law are hereby designated and appointed election officers for the holding of this election. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law. Early voting in the election by personal appearance shall begin on October 16, 2021, and shall continue through October 29, 2021, unless extended by the Governor of Texas.

The Clerk for Early Voting in Collin County is Bruce Sherbet, and early voting will be conducted at polling locations established by Collin County for early voting. The Collin County Early Voting Clerk's mailing address to which ballot applications and ballots to be voted by mail may be sent is: Collin County Elections Department, 2010 Redbud Blvd., Suite 102, McKinney, Texas 75069. The early voting clerk's email address is election@collincountytx.gov.

Section 6: The election shall be held and conducted and returns made of this election in accordance with the Texas Election Code, as modified by Chapter 65 of the Texas Water Code.

Section 7: All qualified residents of the District shall be entitled to vote in the election.

Section 8: The Secretary of the Board of Directors is hereby directed to cause notice of this election to be published in both Spanish and English in a newspaper of general circulation within the District pursuant to §4.003 of the Election Code.

AN ORDER OF THE MUSTANG SPECIAL UTILITY DISTRICT ESTABLISHING PROCEDURES FOR A SPECIAL ELECTION TO BE HELD ON NOVEMBER 2, 2021 TO CONSIDER PROPOSITION 1; CONSOLIDATION OF MUSTANG SPECIAL UTILITY DISTRICT AND MARILEE SPECIAL UTILITY DISTRICT; AND PROVIDING DETAILS RELATING TO THE HOLDING OF SUCH ELECTION. BE IT ORDAINED BY THE MUSTANG SPECIAL UTILITY DISTRICT BOARD OF DIRECTORS:

- Section 1. In accordance with the general laws and Constitution of the State of Texas, a Special Election is hereby called and ordered for the first Tuesday in November 2021, the same being the 2nd day of said month, at which election all qualified voters of the District may vote for the purpose of this proposition.
- Section 2. The District polling place shall be Mustang SUD offices, 7985 FM 2931, Aubrey, TX 76227. The polls shall, on said Election Day, be open from seven o'clock (7:00) a.m. to seven o'clock (7:00) p.m.
- Section 3. The District will appoint at a later date the Presiding Judge and the Alternate Presiding Judge. The Presiding Judge will then appoint the clerks of the election in a number not to exceed two clerks.
- Section 4. In accordance with Sec, 51 of the Election Code, the Election Administrator is hereby authorized and instructed to secure and furnish all necessary election supplies to conduct said election. Section 49.111 of the Texas Water Code Exempts Mustang SUD from the acquisition, lease, or use of an electronic voting system, therefore voting at such election shall be by paper ballots. Any voter of the District may request the use of a voting station that meets the accessibility requirements for voting in person with a disability. Requests must be received no later than the 45th day before the election. Such request should be mailed to Mustang SUD, Attention; Jennifer Bland at 7985 FM 2931. Aubrey, TX 76227. Requests may also be faxed to 940-440-9686 or emailed to jbland@mustangwater.com.
- Section 5. The Assistant General Manager, the Executive Administrative Assistant, and the Public Relations Assistant are hereby appointed clerks for early voting. The early voting for the abovedesignated election shall be at Mustang SUD Office, 7985 FM 2931, Aubrey, TX 76227.

Said place of early voting shall remain open for at least eight (8) hours on each day for early voting which is not a Saturday or Sunday, or an official state or federal holiday, beginning on the 12th day before the election and continuing through the 4th day preceding the date of said election (October 18, 2021 through October 29, 2021). Section 85.001(e) for an election held on a uniform election date in November, the period for early voting by personal appearance begins on the 12th day before Election Day and continues through the 4th day before the Election Day. Said places of early voting shall remain open from eight o'clock (8:00) a.m. to five o'clock (5:00) p.m. on each day for said early voting.

The early voting clerk's address to which ballot applications may be requested and ballots voted by mail may be mailed to P.O. Box 1720, Denton, TX 76202. If you choose to use a contract carrier, applications can be delivered to:

Application for ballots by mail must be received no later than the close of business on Friday, October 22, 2021.

- Section 6. Early voting, both by personal appearance and by mail, shall be by paper ballots and shall be canvassed by an Early Voting Ballot Board.
- Section 7. Said election shall be held in accordance with the Texas Election Code. All qualified voters of the District shall be eligible to vote at said election for the purpose of this consolidation proposition.
- Section 8. The Board of Directors shall give notice of this election in accordance with the terms and provisions of the Texas Election Code, and all necessary orders and writs for said election shall be issued by the proper authority.
- Section 9. The Board of Directors of the Mustang Special Utility District recognizes the following District employees for the purpose of conducting the District's Special Election. The Election Administrator and Early Voting Clerk shall be Jennifer Bland, MSUD Assistant General Manager. The Deputy Barly Voting Clerks shall be Bonnie Larson, Executive Administrative Assistant and Emily Davis, Public Relations Assistant.

ORDER CANVASSING THE RETURNS AND DECLARING THE RESULTS OF NOVEMBER 2, 2021 ELECTION AUTHORIZING CONSOLIDATION OF MARILEE SPECIAL UTILITY DISTRICT

AND MUSTANG SPECIAL UTILITY DISTRICT

COUNTY OF COLLIN

WHEREAS, on November 2, 2021, an election was held in Marilee Special Utility District (the "District"), in accordance with Sections 65.723 and 65.724 of the Texas Water Code, on a proposition to authorize the District to consolidate with Mustang Special Utility District; and

WHEREAS, the Board of Directors duly ordered an election for November 2, 2021, appointed election officials required for the conduct of the election, and deemed it advisable to call the election; and

WHEREAS, the votes cast at the election have been counted and recorded on the official election returns, and the returns have been certified and filed with the Board of Directors by the appropriate election officials; and

WHEREAS, the returns show 123 votes for the proposition to authorize the District to consolidate with Mustang Special Utility District and 60 votes against; and

WHEREAS, the election was called and held in conformity with the Constitutions and laws of the State of Texas and the United States of America; and

WHEREAS, the meeting to adopt this Order was open to the public, and public notice of the time, place, and purpose of the meeting was given, all as required by Chapter 551, Government Code, as amended.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF MARILEE SPECIAL UTILITY DISTRICT THAT:

Section 1. All recitals above are true and correct and are incorporated in this Order.

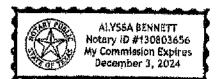

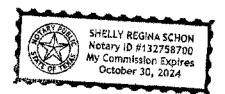
