RE: Project No. 54131, Consolidation of Marilee SUD into Mustang SUD.

Dear Mr. Boyd and Mustang SUD:

On December 8, 2023, the Public Utility Commission of Texas (Commission) received the request to update CCN records to reflect the consolidation of Marilee Special Utility District (SUD) into Mustang SUD and the name change of Marilee SUD, CCN No. 10150, to Mustang SUD, under Texas Water Code (TWC), Chapter 13.041 (a), and 30 Texas Administrative Code (TAC) §§293.101 through 293.103.

According to Texas Commission on Environmental Quality (TCEQ) Water District Database, on September 15, 2022, the TCEQ consolidated the districts of Marilee SUD and Mustang SUD under TWC Chapters 49.071 and 65 in Sections 65.723 through 65.726; 30 TAC §293.101 through 293.103; and the procedural rules of the TCEQ. Marilee SUD and Mustang SUD filed a Consolidation Agreement entered on August 9, 2021 and the following documents from each of the districts as evidence of the consolidation:

- 1. Order calling the election for consolidation;
- 2. Official election returns;
- 3. Order Canvassing the Returns and Declaring the Results of the November 2, 2021 Election authorizing consolidation of Marilee SUD and Mustang SUD as approved on November 9-10, 2021; and
- 4. Resolutions acknowledging the consolidation of Marilee SUD with Mustang SUD.

As part of the consolidation, Marilee SUD and Mustang SUD filed the required resolution acknowledging the consolidation of Marilee SUD with Mustang SUD approved by the Board of Directors held by both districts on January 24, 2022. On November 30, 2023, you signed the affidavit confirming the transfer of Marilee SUD's assets and liabilities to Mustang SUD.

The evidence provided in Project No. 54131 is adequate to update the name for CCN No. 10150 to Mustang SUD. Enclosed is a copy of the new Certificate of Convenience and Necessity for water CCN No. 10150 reflecting the name change from Marilee SUD to Mustang SUD in Project No. 54131. The Commission's records have been updated accordingly. No boundary change has been made to CCN No. 10150 in Project No. 54131.
