**COMMISSION STAFF'S NOTICE OF CHANGE OF COUNSEL  
AND REQUEST FOR EXTENSION**

On September 23, 2022, Rio Concho Aviation, Inc (Rio Concho) filed an application to implement a pass-through rate change under 16 Texas Administrative Code (TAC) § 24.25(b)(2) for an increase in fees billed by Northern Trinity Groundwater Conservation District (NTGCD). NTGCD raised the fee charged to Rio Concho to \$0.155 per thousand gallons effective January 1, 2022.

On February 23, 2023, the administrative law judge (ALJ) filed Order No. 7, establishing a deadline of March 8, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file finalize and submit a proposed procedural schedule. Therefore, this pleading is timely filed.

**I. CHANGE OF COUNSEL**

Marisa Lopez Wagley has replaced Kevin Bartz as Staff's attorney of record in this proceeding. Please direct all correspondence and communication to the undersigned attorney.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review and finalize the proposed procedural schedule. Therefore, Staff respectfully requests that Staff's deadline to file a response to Order No. 7 be extended until March 16, 2023.

**III. CONCLUSION**

For the reasons detailed above, Staff requests that the deadline to file a proposed procedural schedule for further processing of the application be extended until March 16, 2023.
