COMMISSION STAFF'S JOINT REQUEST FOR EXTENSION

On September 23, 2022, Rio Concho Aviation, Inc. (Rio Concho) filed an application to under 16 Texas Administrative Code (TAC) § 24.25(b)(2) for approval of a proposed pass-through rate change related to an increase in the fees billed by Northern Trinity Groundwater Conservation District. The increase by Northern Trinity Groundwater Conservation raised the fee charged to Rio Concho to \$0.155 per thousand gallons effective January 1, 2022.

On May 23, 2023, the administrative law judge (ALJ) filed Order No. 10, establishing a deadline of June 1, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Rio Concho to submit a joint motion to admit evidence.

I. JOINT REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working with Rio Concho to review and finalize the joint motion to admit evidence and proposed notice of approval. Staff has conferred with Rio Concho and is authorized to represent that they join Staff in this extension request. Therefore, Staff respectfully requests that the parties deadline to file a joint motion to admit evidence be extended until June 29, 2023.

II. CONCLUSION

For the reasons detailed above, Staff requests that the deadline to file a joint motion to admit evidence be extended until June 29, 2023.
