## COMMISSION STAFF'S AMENDED SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND RESPONSE TO ORDER NO. 8

On September 23, 2022, Rolling V Water Control and Improvement District No. 3 (Rolling V WCID No. 3) filed an application to obtain a water certificate of convenience and necessity (CCN) and for dual certification with the City of Rhome in Wise County. Rolling V WCID No. 3 filed supplemental information on October 21 and November 4, 2022, February 16 and March 3, 2023.

On April 11, 2023, the administrative law judge (ALJ) filed Order No. 8, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the administrative completeness of the application from a financial standpoint by April 25, 2023. Therefore, this pleading is timely filed.

#### I. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the application and supplemental information and, as detailed in the attached memorandum from Jolie Mathis, Infrastructure Division recommends that the application is incomplete from a managerial and technical perspective. Fred Bednarski, Rate Regulation Division, recommends that the application is administratively complete. Staff further recommends that Rolling V WCID No. 3 be ordered to cure the deficiencies identified in Ms. Mathis' memorandum by May 10, 2023 and that Staff be given a deadline of June 9, 2023 to file a supplemental recommendation on the administrative completeness of the application. Staff respectfully requests adoption of these proposed deadlines as some of the noted deficiencies are related to mapping information and Staff's mapping experts may be required to assist Rolling V WCID No. 3 regarding the supplemental mapping information needed to cure the mapping deficiencies and will require at least thirty days to review the same.

Π. PROCEDURAL SCHEDULE

In accordance with Staff's deficiency recommendation, Staff does not propose a procedural

schedule for further processing of the docket at this time. Staff intends to propose a procedural

schedule alongside a subsequent recommendation that the application be found administratively

complete. Staff notes that Rolling V WCID No. 3 should not issue notice until the application is

deemed sufficient.

Ш. CONCLUSION

For the reasons detailed above, Staff recommends that the application be found

administratively incomplete, and that Rolling V WCID No. 3 be ordered to file supplemental

information to cure the deficiencies in the application by May 10, 2023. Staff respectfully requests

the entry of an order consistent with these recommendations.

On September 23, 2022, Rolling V Ranch Water Control and Improvement District No. 3 of Wise County (Rolling V WCID) filed with the Public Utility Commission of Texas (Commission) an application to obtain a water certificate of convenience and necessity (CCN) and for dual certification with the City of Rhome (Rhome) in Wise County, Texas under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237.

Based on my technical and managerial review of the additional information filed by Rolling V WCIS on March 3, 2023, I recommend that the application be deemed administratively incomplete and not accepted for filing.

### **Application and Mapping Content:**

Rolling V WCID No. 3 is seeking dual certification with Rhome (CCN No. 10989) for the entire requested area:

- 1) Under 16 TAC § 24.233(a)(12) applicants requesting dual certification with another utility must provide a copy of an agreement with the other utility that allows the dual certification. Please provide an agreement from Rolling V Ranch WCID No. 3 of Wise County that specifies the acreage agreed to have dual certification with City of Rhome (CCN No. 10989).
- 2) Please specify the number of existing customer connections in the requested area.

On September 23, 2022, Rolling V Water Control and Improvement District No. 3 of Wise County (Rolling V WCID No. 3) filed an application to obtain a water Certificate of Convenience and Necessity and for dual certification with the City of Rhome in Wise County under Subchapter G of Texas Water Code Chapter 13.

I reviewed the answers provided to questions 28, 29, 30, and 31 of the application. I did not identify any deficiencies in those answers for purposes of determining whether the ap-plication is administratively complete. Therefore, I recommend that the Commission deem the application administratively complete from a financial perspective.
