### COMMISSION STAFF'S REQUEST FOR EXTENSION

On September 23, 2022, Rolling V Water Control and Improvement District No. 3 (Rolling V WCID No. 3) filed an application to obtain a water certificate of convenience and necessity (CCN) and for dual certification with the City of Rhome in Wise County.

On August 10, 2023, the administrative law judge (ALJ) filed Order No. 11, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice by October 5, 2023. Therefore, this pleading is timely filed.

# I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working with Rolling V WCID No. 3 to resolve an issue with the publisher's affidavit submitted by Rolling V WCID No. 3 on September 25, 2023. Therefore, Staff respectfully requests that Staff's deadline to file its recommendation on sufficiency of notice in response to Order No. 11 be extended until October 18, 2023.

#### II. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request for extension.
