COMMISSION STAFF'S CLARIFICATION

On September 23, 2022, Rolling V Water Control and Improvement District No. 3 (Rolling V Ranch) filed an application to obtain a water certificate of convenience and necessity (CCN) and for dual certification with the City of Rhome in Wise County.

On May 22, 2024, the administrative law judge (ALJ) filed Order No. 21, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Rolling V Ranch to file briefing on issues identified in Order No. 21, if the requested area is wholly inside the city limits of Rhome by June 4, 2024. On June 4, 2024, Staff and Rolling V Ranch filed a joint response.

I. CLARIFICATION

The joint response, filed on June 4, 2024, stated "[a]ll of the requested area is located within the extraterritorial jurisdiction of Rhome." After further review by Staff's mapping specialist, Staff has determined that the requested area is not located wholly within the extraterritorial jurisdiction of Rhome. Rather, a portion of the requested area is overlapping with the City of Rhome's city limits. However, because the requested area is not wholly inside the city limits of Rhome, the questions provided for briefing in Order No. 21 do not apply. If the ALJ requires further clarification, Staff respectfully requests that a deadline be set for any subsequent clarification.
