**COMMISSION STAFF'S EXCEPTIONS AND CORRECTIONS  
TO THE AMENDED PROPOSED ORDER**

On September 23, 2022, Rolling V Water Control and Improvement District No. 3 (Rolling V WCID No. 3) filed an application to obtain a water certificate of convenience and necessity (CCN) and for dual certification with the City of Rhome in Wise County.

On June 25, 2024, the Office of Policy and Docket Management filed an Amended Proposed Order (PO), directing the parties to file exceptions or corrections to the amended PO by July 2, 2024. Therefore, this pleading is timely filed.

**I. EXCEPTIONS AND CORRECTIONS**

Staff (Staff) of the Public Utility Commission of Texas (Commission) has reviewed the PO and respectfully proposes the following exceptions and corrections to the PO:

1. Add the following ordering paragraph after Ordering Paragraph No. 1:
  - X. The Commission dually certifies Rolling V Ranch water CCN number 13315 and a portion of Rhome's water CCN number 10989 as described in this proposed order and shown on the attached map.

The preceding correction is needed to address the request in the application to dually certify Rolling V Ranch's water CCN with a portion of Rhome's water CCN. It also accurately reflects the change as depicted in the map attached to the PO.

**II. CONCLUSION**

Staff respectfully recommends that the PO be revised in accordance with the corrections proposed above.
