#### **COMMISSION STAFF'S CORRECTED NOTICE DOCUMENT**

On September 27, 2022, Olsen Estates Property Owner's Association (Olsen Estates) filed an application for a Class D rate adjustment under Texas Water Code (TWC) § 13.1872 and 16 Texas Administrative Code (TAC) § 24.49. Olsen Estates holds water Certificate and Convenience and Necessity (CCN) No. 13160. The application indicates there are 57 active water connections. Olen Estates filed supplemental information on November 3, 2022.

On December 9, 2022, the administrative law judge (ALJ) filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a corrected copy of the notice Staff recommends be used by the applicant by December 16, 2022. Therefore, this pleading is timely filed.

#### I. CORRECTED NOTICE DOCUMENT

In its previous filing, Staff inadvertently attached a notice form which included the wrong dates for when notice will be provided and when the new rates will go into effect. Staff has attached a corrected notice document to this pleading.

#### **II. CONCLUSION**

As explained in its supplemental recommendation on administrative completeness and final disposition filed on December 5, 2022, Staff recommends Olsen Estates provide notice of the new rate, using only the notice pages approved by the ALJ, by January 9, 2023, to be effective on February 9, 2023. Staff respectfully requests the entry of an order consistent with these recommendations.
