COMMISSION STAFF’S REQUEST FOR EXTENSION

On September 27, 2022, Oak Bend Homeowners’ Water Supply Corporation (Oak Bend) filed an application for authority to change water rates under Texas Water Code (TWC) §§ 13.1871 and 13.18715. Oak Bend is a Class D water utility and holds water Certificate of Convenience and Necessity (CCN) No. 11633.

On January 25, 2023, the administrative law judge (ALJ) filed Order No. 5, granting Staff’s request for extension and establishing a deadline of February 17, 2023 for the Staff (Staff) of the Public Utility Commission of Texas (Staff) to file comments on the administrative completeness of the application, proposed notice, and to propose a procedural schedule for the further processing of this docket. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to continue working with the Applicant to resolve the final deficiency in the docket. As such, Staff requests that the deadline to file comments on the administrative completeness of the application, proposed notice, and a proposed procedural schedule be extended until February 24, 2023.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending Staff’s deadline to file comments on the administrative completeness of the application, proposed notice, and a proposed procedural schedule until February 24, 2023.
