## ORDER NO. 7 FINDING APPLICATION ADMINISTRATIVELY COMPLETE, PROPOSED NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the September 27, 2022 application of Oak Bend Homeowner's Water Supply Corporation for authority to change water rates. On November 29, 2022, Oak Bend filed an affidavit attesting to the provision of notice to current customers and affective parties. On February 9, 2023, Oak Bend filed supplemental information.

On February 24, 2023 Commission Staff filed a supplemental recommendation on the sufficiency of the application and proposed notice.

The administrative law judge finds the application administratively complete and proposed notice sufficient.

The following procedural schedule is established for continued processing:

Proposed effective date of rate change	February 1, 2023
Deadline to intervene, comment, or request a hearing (90 days from the effective date of February 2023) <sup>1</sup>	May 2, 2023
Deadline for Commission Staff to request a hearing or file a recommendation on final disposition	May 11, 2023
Deadline for applicant to respond to Commission Staff's recommendation, or if no disputed issues exist, deadline for parties to file proposed findings of fact, conclusions of law, and ordering paragraphs	May 18, 2023

 $<sup>^1</sup>$  Under 16 Texas Administrative Code (TAC) § 24.35(c)(2), if during the first 90 days after the effective date of the rate change, the Commission receives a complaint from any affected municipality, or protests from the lesser of 1,000 or 10% of the ratepayers of the utility over whose rates the Commission has original jurisdiction, the Commission shall set the matter for hearing.

Deadline for the Commission to set the matter for a hearing	Luna 1, 2022
on its own (120 <sup>th</sup> day after the effective date) <sup>2</sup>	June 1, 2023
