AGREED REQUEST FOR EXTENSION

Texas Water Utilities, L.P. (TWU) files this Agreed Request for Extension of time to file the joint motion to admit evidence and proposed order approving the sale and allowing the transaction to proceed, pursuant to the Order No. 6 issued on January 3, 2023. In support, TWU would show the following:

I. BACKGROUND

On September 30, 2022, Monarch Utilities I L.P. (Monarch) and CS Water Corporation (CS Water) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Bosque County, Texas, under Texas Water Code § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. On November 29, 2022, the administrative law judge (ALJ) issued Order No. 4, recognizing that Monarch had changed its name to Texas Water Utilities, L.P. on November 15, 2022, and restyling the application accordingly.

On January 3, 2023, the ALJ filed Order No. 6, directing TWU, CS Water, Public Utility Commission of Texas (Commission) Staff, and the Office of Public Utility Counsel (OPUC) to file a joint motion to admit evidence and proposed order approving the sale and allowing the transaction to proceed by March 10, 2023.

II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), TWU requests that the ALJ extend the deadline to file the joint motion to admit evidence and proposed order approving the sale and allowing the transaction to proceed to March 14, 2023. TWU, CS Water, Commission Staff, and OPUC need additional time to continue drafting and reviewing the required filing. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. TWU has conferred with counsel for Commission Staff and counsel for OPUC, and is authorized to represent that Commission Staff and OPUC agree to the requested extension.

III. CONCLUSION

TWU respectfully requests the issuance of an order granting its request and extending the deadline to file the joint motion to admit evidence and proposed order approving the sale and allowing the transaction to proceed to March 14, 2023.
