AGREED REQUEST TO MODIFY PROCEDURAL SCHEDULE

Texas Water Utilities, L.P. (TWU) and CS Water Corporation (CS Water) (collectively, the applicants) and the Public Utility Commission of Texas (Commission) Staff respectfully request to modify the procedural schedule established in Order No. 10. To facilitate the timely processing of this docket, TWU and Staff conferred on the form of the new notice to be provided to customers before Order No. 10 was filed. In addition, TWU mailed the new notice to customers and affected parties on April 19, 2023. Using this notice date, the deadline for applicants to file a supplemental motion to admit evidence and revised proposed order approving the sale and transfer to proceed would be May 29, 2023 under Order No. 10, which is before the June 2, 2023 for Staff to file a recommendation on the sufficiency of the new notice.

To avoid confusion, the applicants and Staff request to modify the procedural schedule as follows:

Deadline for parties to file a response to Commission Staff's recommendation	May 24, 2023
