**COMMISSION STAFF’S REQUEST FOR EXTENSION**

**I. INTRODUCTION**

On September 30, 2022, Texas Water Utilities, LP and the CS Water Corporation (collectively, Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Bosque County, Texas, under Texas Water Code § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. Texas Water filed supplemental information on October 4, October 25, and October 26, 2022; November 1 and November 23, 2022; and February 10, 2023.

On May 31, 2023, the administrative law judge (ALJ) filed Order No. 14, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file recommendations on whether Applicants’ capital improvement plans satisfy Commission requirements, on the loan documentation or request for a good cause exception, on Applicants’ supplemental notice, and on Applicants’ supplemental materials by July 7, 2023.

**II. REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is working with Applicants regarding additional information needed for Staff to formulate its recommendation. Therefore, Staff respectfully requests that the deadline for Staff to file a recommendation on whether Applicants' capital improvement plans satisfy Commission requirements, on the loan documentation or request for a good cause exception, on Applicants' supplemental notice, and on Applicants' supplemental materials be extended until July 14, 2023.

**III. CONCLUSION**

For the reasons stated above, Staff respectfully requests that the deadline for Staff to file a recommendation on whether Applicants' capital improvement plans satisfy Commission

requirements, on the loan documentation or request for a good cause exception, on Applicants' supplemental notice, and on Applicants' supplemental materials be extended until July 14, 2023.
