JOINT CLARIFICATION IN RESPONSE TO ORDER NO. 23

Texas Water Utilities, L.P. (TWU) and the Staff (Staff) of the Public Utility Commission of Texas (Commission) submit the following clarification regarding the modifications to the final tariff for this proceeding proposed by Commission Staff.¹

I. CLARIFICATION REGARDING TARIFF MODIFICATIONS

The tariff Commission Staff provided to TWU via email on April 5, 2024, was modified in three ways:

- CS Water was added to the list of systems to which the System Improvement Charge (SIC) does not apply because TWU's SIC was not in effect at the time the application was filed, and therefore as not eligible to be included in a request for initial rates under Texas Water Code § 13.3011.
- 2. CS Water was added to the list of systems for which no water pass-through rate is applicable.
- 3. All references to "Tariff Control No. 54171" were changed to "Docket No. 54171."

The tariff pages provided in Attachment B to the Third Supplemental Joint Motion to Admit Evidence and Proposed Notice of Approval include these agreed upon modifications.

II. CONCLUSION

TWU and Commission Staff respectfully submit this clarification in response to Order No. 23.
