## COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION

On October 28, 2022, SJWTX, Inc. DBS Canyon Lake Water Service Company and San Antonio Water System (Applicants) filed an application for approval of a service-area contract under Texas Water Code § 13.248 and to amend a certificate of convenience and necessity in Kendall County.

On January 4, 2023, the administrative law judge (ALJ) filed Order No. 4, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule by January 31, 2023. Therefore, this pleading is timely filed.

#### I. REOUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. On January 25, 2023, Applicants filed supplemental documents in this docket. Staff needs more time to conduct a formal review and make a recommendation on the administrative completeness of the application. Staff requests that the deadline to file a supplemental recommendation regarding the administrative completeness of the petition, along with a proposed procedural schedule, if appropriate be extended to February 22, 2023.

#### II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to February 22, 2023, to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule.
