**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On October 28, 2022, SJWTX, Inc. DBS Canyon Lake Water Service Company and San Antonio Water System (Applicants) filed an application for approval of a service-area contract under Texas Water Code § 13.248 and to amend a certificate of convenience and necessity in Kendall County.

On January 31, 2023, the administrative law judge (ALJ) filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule by February 22, 2023. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. On January 25, 2023, Applicants filed supplemental documents in this docket. Staff needs a short extension to finish conducting its formal review and make a recommendation on the administrative completeness of the application. Staff respectfully requests an extension of time until March 1, 2023 for further review on the Application.

**II. CONCLUSION**

Staff respectfully requests the entry of an order extending Staff’s deadline to March 1, 2023, to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule.
