**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On October 28, 2022, SJWTX, Inc. DBA Canyon Lake Water Service Company and San Antonio Water System (Applicants) filed an application for approval of a service-area contract under Texas Water Code § 13.248 and to amend a certificate of convenience and necessity in Kendall County.

On October 31, 2022, the administrative law judge (ALJ) filed Order No. 1, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule by November 28, 2022. On November 28, 2022, Staff filed its request for extension.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff is working with Applicants to resolve deficiencies in the application. On November 28, 2022, Staff inadvertently request an extension until December 2, 2022. Staff intended to respectfully request an extension of time until December 29, 2022 for further review on the Application.

**II. CONCLUSION**

Staff respectfully requests the entry of an order extending Staff’s deadline to December 29, 2022, to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule.
