COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION

On October 28, 2022, SJWTX, Inc. DBS Canyon Lake Water Service Company and San Antonio Water System (Applicants) filed an application for approval of a service-area contract under Texas Water Code § 13.248 and to amend a certificate of convenience and necessity in Kendall County.

On November 30, 2022, the administrative law judge (ALJ) filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule by December 29, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff is working with Applicants to resolve mapping deficiencies. Staff respectfully requests an extension of time until January 31, 2023 for further review on the Application.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to January 31, 2023, to file comments on the administrative completeness of the petition, comments on notice, and propose a procedural schedule.
