COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

I. INTRODUCTION

On October 31, 2022, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and Douglas Utility Company c/o Zieben Group (Douglas Utility) (collectively, Applicants) filed an application for the sale, transfer, or merger (STM) of facilities and certificate rights in Harris County, under Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. CSWR-Texas filed supplemental information on November 17, 18, 21, 2022 and December 2, 2022.

On January 31, 2023, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline of February 6, 2023, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a proposed procedural schedule for continued processing of this application. Therefore, this pleading is timely filed.

II. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule for continued processing of this application:
