**ORDER NO. 10**  
**FINDING CLOSING DOCUMENTS SUFFICIENT AND**  
**ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's October 31, 2023, recommendation regarding the closing documentation filed by CSWR-Texas Utility Operating Company, LLC and Douglas Utility Company C/O Zieben Group and proposed procedural schedule for continued processing.

On October 17, 2023, the applicants filed a bill of sale signed by both the transferor and the transferee and assigning Douglas Utility's water and sewer systems to CSWR-Texas. The effective date of the transaction is listed on the bill of sale as July 26, 2023, and the bill of sale was signed by the transferor and transferee on July 21 and July 26, 2023. Also on October 17, 2023, the applicants filed a notarized affidavit, dated October 12, 2023, and signed by Alan Zieben, president of Douglas Utility, attesting that all customer deposits held by Douglas Utility were returned or refunded to customers by October 7, 2023. Commission Staff recommended the closing documentation be found sufficient.


The administrative law judge finds the closing documentation sufficient.
