**COMMISSION STAFF'S PROOF OF NOTICE**

On November 2, 2022, the Staff of the Public Utility Commission of Texas filed a Petition seeking an order directing the distribution of the PURA<sup>1</sup> Chapter 39, Subchapter N proceeds held by the Electric Reliability Council of Texas (ERCOT) that are designated for Iberdrola Solutions LLC (Iberdrola).

On November 3, 2022, the administrative law judge (ALJ) filed Order No. 1, directing Commission Staff to provide proof of notice by November 9, 2022. Therefore, this pleading is timely filed.

**I. NOTICE OF THIS PROCEEDING**

On November 2, 2022, Commission Staff sent a copy of the Petition via email to representatives of ERCOT and Iberdrola.
