THERE IS NO CLIMATE CRISIS

Policy makers around the world rush with futility to save the world from changes in climate, ignoring or dismissing the extensive collateral damage they impose on humanity. The following is the summary statement of The Right Climate Stuff Research Team (TRCS) after voluntarily researching and consulting with the most highly qualified climate scientists for the past ten years. The errors in input data and errors in the modeling of some of the climate forcing functions have caused overprediction of future temperatures <u>by up to 300%</u>
- **7.** Unreliable wind and solar power generation are creating instability to power grids, and would not be economical without subsidies. Both require large, environmentally damaging footprints.
