COMMISSION STAFF'S REVISED FINAL RECOMMENDATION

I. INTRODUCTION

On November 28, 2022, the City of Princeton (Princeton) and Milligan Water Supply Corporation (Milligan) (collectively, the Petitioners) filed an application for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend certificates of convenience and necessity in Collin County.

On July 5, 2023, the administrative law judge (ALJ) filed Order No. 5, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a revised final recommendation by August 9, 2023. Therefore, this pleading is timely filed.

II. RECOMMENDATION

Staff has reviewed the Petitioners' petition and, as detailed in the attached memorandum of Jaspinder Singh of the Infrastructure Division, recommends that the petition be approved. Staff's review indicates that the petition meets the statutory requirements of TWC § 13.248.

III. CONCLUSION

For the reasons detailed above, Staff respectfully recommends that the petition be approved.

On November 28, 2022, Milligan Water Supply Corporation (Milligan WSC) and the City of Princeton (Princeton) (collectively, Petitioners) filed a petition for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend Milligan WSC's water Certificate of Convenience and Necessity (CCN) No. 10188 and Princeton's water CCN No. 13195 in Collin County, Texas. The Petitioners' TWC § 13.248 service area contract is being reviewed in accordance with 16 Texas Administrative Code (TAC) § 24.253.

Based on the mapping review by Hank Journeay, Infrastructure Division, the petition requests the following:

To provide clarification about the agreement maps (named Exhibit B and Exhibit C) and PUC requested maps (named Figure 1 and Figure 2):

Transfer Area 1 (Exhibit C) in the agreement for transfer of portions of Princeton's certificated water service area (CCN No. 13195) to Milligan WSC (CCN No. 10188), is identified as Requested Areas 4-6 on the general location map (Figure 1) and detailed map (Figure 2) and digital mapping data submitted on *January 24, 2023, in Item 6*.

Transfer Area 2 (Exhibit B) in the agreement for transfer of portions of Milligan WSC's certificated water service area (CCN No. 10188) to Princeton (CCN No. 13195), is identified as Requested Areas 1-3 on the general location map (Figure 1) and detailed map (Figure 2) and digital mapping data submitted on *January 24, 2023, in Item 6*.

Transfer Area 1; Requested Areas 4-6: Transfer Portions of Princeton to Milligan WSC

• The requested area includes 0 customer connections and approximately 2.08 acres of transferred area from Princeton (CCN No. 13195) to Milligan WSC (CCN No. 10188).

• The petition proposes the subtraction of approximately 2.08 acres from CCN No. 13195 and the addition of approximately 2.08 acres to CCN No. 10188.

Transfer Area 2; Requested Areas 1-3: Transfer Portions of Milligan WSC to Princeton

- The requested area includes 0 customer connections and approximately 0.53 acres of transferred area from Milligan WSC (CCN No. 10188) to Princeton (CCN No. 13195).
- The petition proposes the subtraction of approximately 0.53 acres from CCN No. 10188 and the addition of approximately 0.53 acres to CCN No. 13195.

Individual Notice was not required for this petition because there are no affected customers in the areas subject to the transfer.

The Petitioners submitted documentation to satisfy the notice requirements under 16 TAC § 24.253(c).

The petition meets all applicable statutory requirements of TWC Chapter 13 and 16 TAC Chapter 24 rules and regulations. Therefore, I recommend approval of the petition.

The Petitioners consented to the attached map and certificates on July 24, 2023.
