CSWR-Texas Utility Operating Company, LLC (“CSWR-Texas”) files this Unopposed Motion for Extension of Time.

In Order No. 11, the Administrative Law Judge ordered the parties to provide a proposed procedural schedule for filing of the capital improvements plan no later than October 12, 2023.
