## COMMISSION STAFF'S REQUEST FOR EXTENSION

#### I. BACKGROUND

On December 6, 2022, Palo Duro Service Company dba Trinity River Estates (Palo Duro) and the City of Hudson Oaks (COHO) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Parker County.

On April 21, 2023, the administrative law judge (ALJ) filed Order No. 4, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file either request a hearing or file a final recommendation on the approval of the sale by June 5, 2023. Therefore, this pleading is timely filed.

## II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff needs additional time to process information before the docket can proceed. Therefore, Staff respectfully requests that the deadline to either request a hearing or file its final recommendation on the approval of the sale be extended until June 9, 2023.

### III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to June 9, 2023, to file its final recommendation on the approval of the sale.
