## COMMISSION STAFF'S REQUEST FOR EXTENSION

On December 6, 2022, Palo Duro Service Company, Inc. and the City of Hudson Oaks (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Parker County.

On September 27, 2023, the administrative law judge (ALJ) filed Order No. 11, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the supplemental information filed by the applicants by October 25, 2023. Therefore, this pleading is timely filed.

# I. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to investigate certain mapping items relating to decertification versus a CCN transfer in order to fully respond to Order No. 11 and to fully evaluate the applicants supplemental filing. Therefore, Staff respectfully requests an extension of time until November 8, 2023.

#### II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to November 8, 2023, to file a supplemental recommendation on the supplemental information filed by the applicants.
