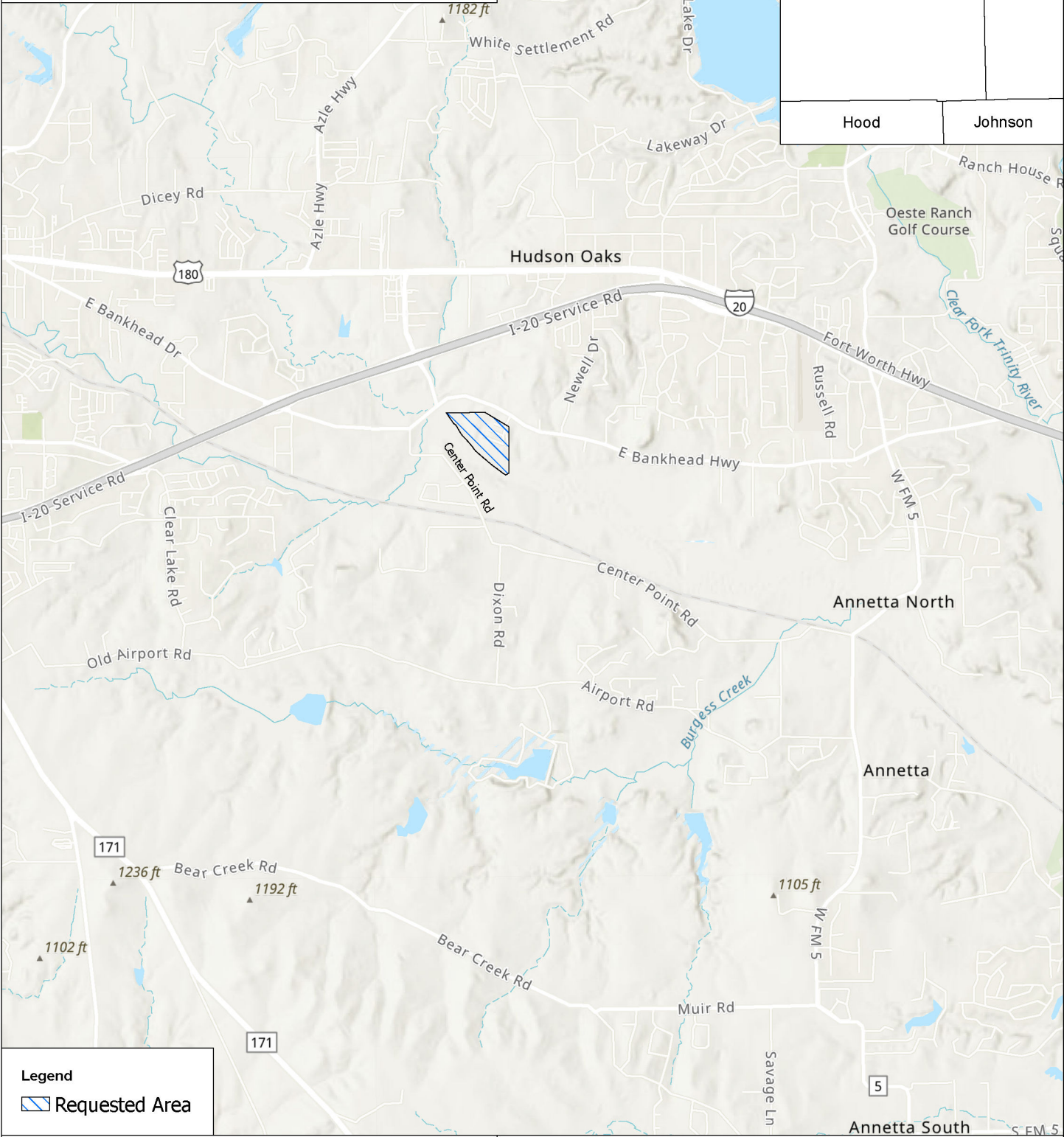
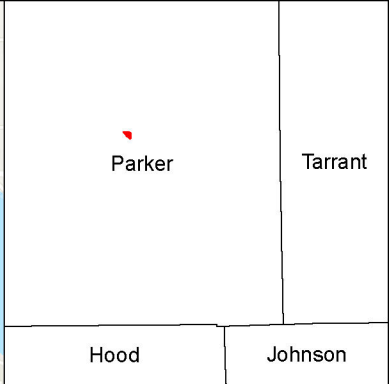
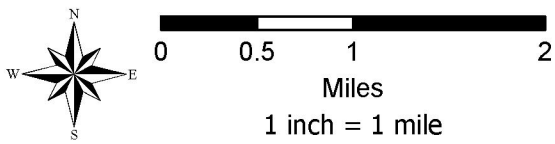

 Requested Area



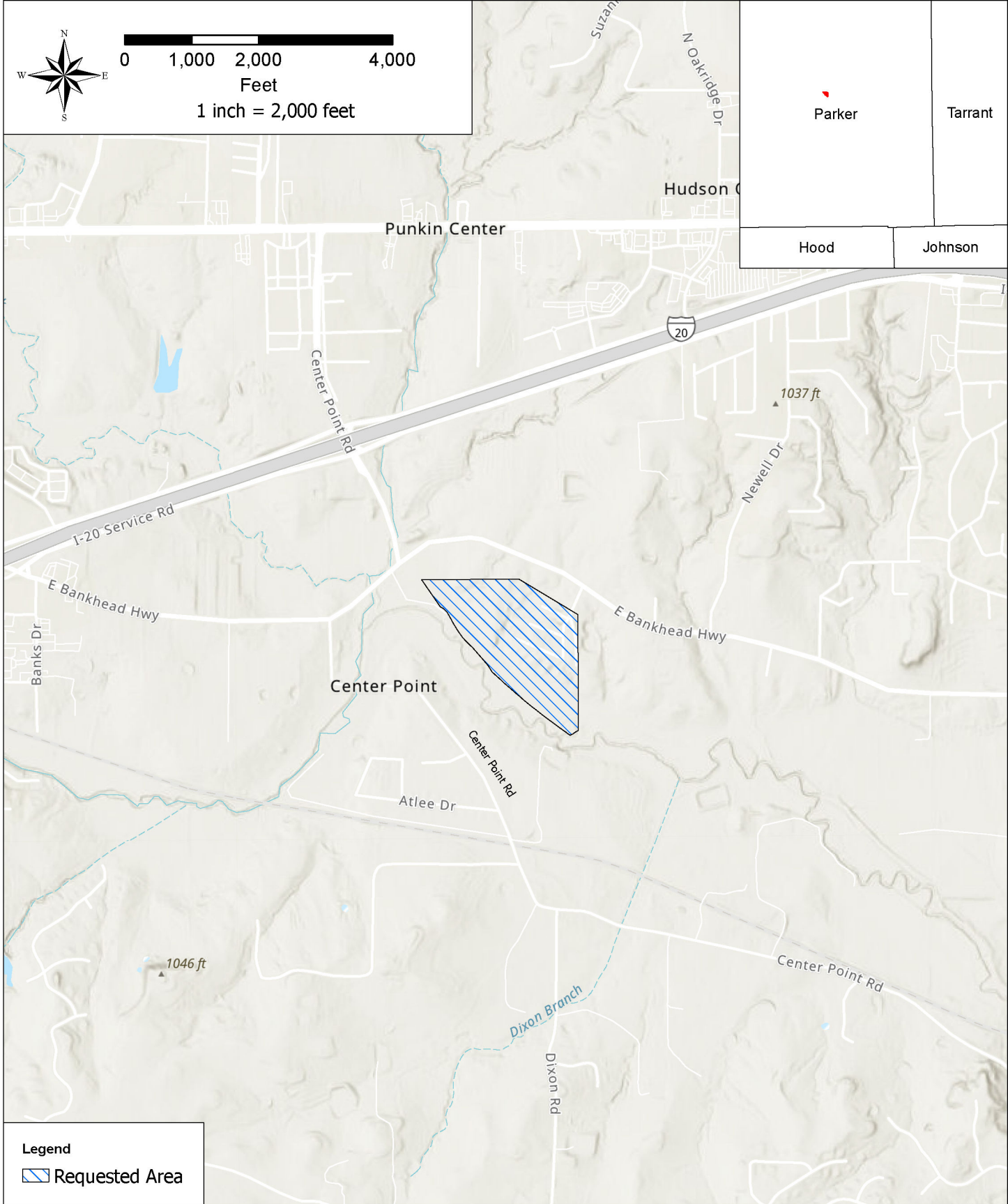

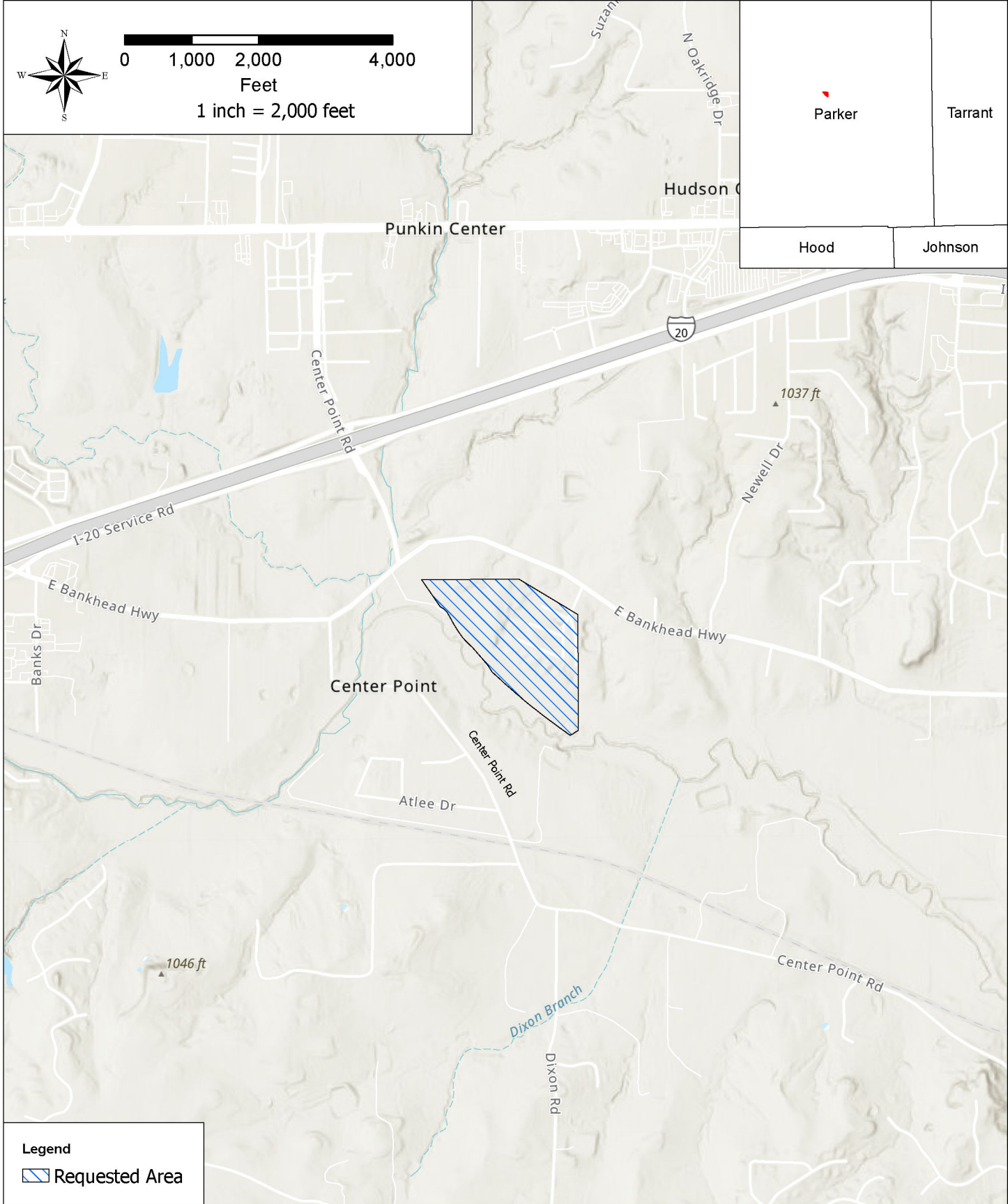
